支払方法

宿泊された宿泊施設へお支払いください。
(旅行者等へ宿泊税を支払われた方は、宿泊施設への支払いは不要です。)

税額

「1人ごと」「1部屋ごと」「1棟ごと」の宿泊料金の設定に応じて

宿泊料金^(※)の2%

(※)宿泊料金とは、素泊まり料金とそれにかかるサービス料などをいいます。
宿泊料金に含まれないもの～消費税、入湯税等に相当する金額
宿泊以外のサービスに相当する料金
(例: 食事代、会議室の利用、電話代等)

Who has to pay the tax

Visitors who stay overnight in lodging facilities in the municipal area of Kutchan Town.

How to pay the tax

Tax will be added to the accommodation fee at the lodging facility in which you are staying.
*If you have made reservations through a travel agency, then the accommodation tax may have been included in the agency's invoice. However, if it wasn't included or you did not make reservations through a travel agency, the tax will be charged by the lodging facility.

Tax Rate

2% of your accommodation fee*

*The accommodation fee doesn't include consumption tax, bathing facility tax, the other service fee. (e.g. meals, use of meeting rooms, telephone bill, etc.)
